Following the designation of the first European Union reference centre for animal welfare, which is responsible for pigs, in 2018 and the second centre, responsible for poultry and other small farmed animals, in 2019, the European Commission has now designated a third EU reference centre for animal welfare, which will be responsible for ruminants and equines.

In order to take account of recent developments in the epidemiological situation of African swine fever in the Union, and in order to combat the risks associated with the spread of that disease in a proactive manner, new restricted zones of sufficient size should be demarcated for some Member States and duly listed in Annex I to Implementing Regulation (EU) 2021/605.

This draft Implementing Regulation lays down special temporary disease control measures regarding infection with lumpy skin disease virus to be applied by Member States for a limited period of time, in addition to the measures applied in the event of an outbreak of that disease provided for in Delegated Regulation (EU) 2020/687.
